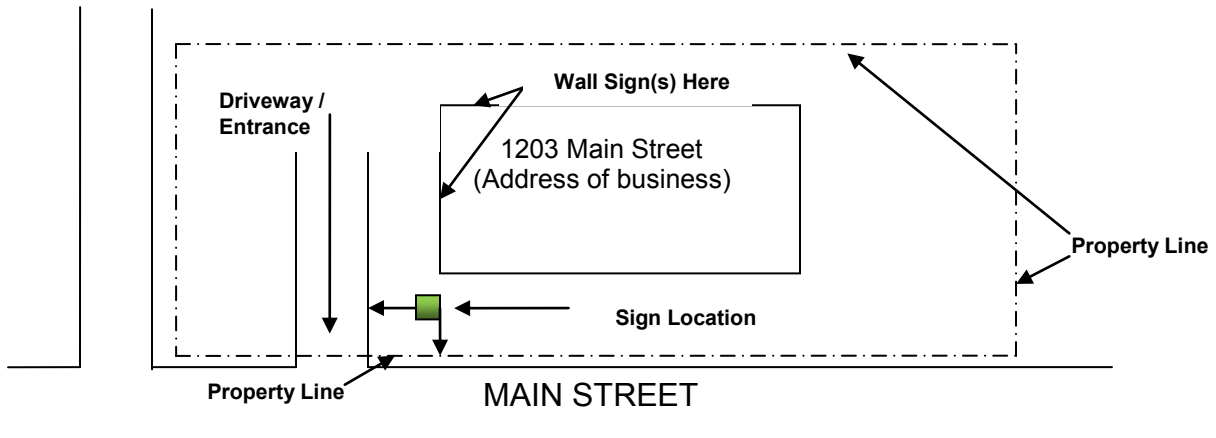


Site Plan Example: Signs (Please Read before applying)

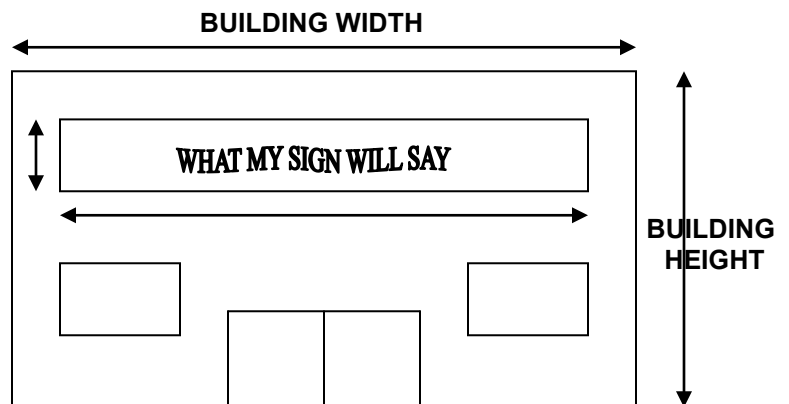
